### Elder Abuse: toward a definition...

- ▶ In general, elder abuse is any knowing, intentional, or negligent act by a caregiver or any other person that causes harm or a serious risk of harm to an older adult.
- ▶ Defined by age, relationship, type of abuse
- ▶ Victims are often on a continuum from active to having various medical, cognitive, mobility issues
- ▶ 2/3 of perpetrators of elder abuse are family members, trusted individuals and/or caregivers

### Prevalence

- ▶ 1,000,000 – 2,000,000 adults in later life in U.S. are victims of abuse<sup>1</sup>
- ▶ 1 in 10 persons over the age 60 are victims of elder abuse<sup>2</sup>
- ▶ Victims of elder financial abuse in U.S. lose close to \$3 Billion each year<sup>3</sup>



## Types of Abuse

- ▶ Domestic Violence Late in Life
- ▶ Physical abuse
- ▶ Emotional abuse
- ▶ Sexual abuse
- ▶ Spiritual abuse
- ▶ Financial Exploitation
- ▶ Neglect
- ▶ Self Neglect

## Abuse Warning Signs

- ▶ Physical – bruises, pressure marks, broken bones, burns, weight loss, malnutrition, poor hygiene
- ▶ Financial – abrupt transfers, changes to Power of Attorney or will, unpaid bills, valuable items removed from elder's home
- ▶ Spiritual – elder prevented from participating in ceremonial and spiritual events
- ▶ Changes in Behavior – strained relationships between caregiver and elderly person, withdrawal from normal activities, unusual depression, change in alertness

### What can we do when we suspect abuse is happening?

- ▶ Share our suspicions – talk to someone – make a report...
- ▶ To emergency services
- ▶ To law enforcement
- ▶ To adult protection
- ▶ To a Tribal Court
- ▶ To an advocacy organization

### The Minnesota Adult Abuse Reporting Center

- ▶ MN DHS single common entry point for maltreatment reports
- ▶ Previously, reports received by each county individually (sometime to multiple contacts within individual counties)
- ▶ MAARC accepts voluntary and mandatory reports

### The Minnesota Adult Abuse Reporting Center

Mandated reporters are professionals or professional's delegate identified by law who **MUST** make a report if they have reason to believe that the abuse, neglect, or financial exploitation of a vulnerable adult has occurred. "Mandated reporter" means a professional or professional's delegate while engaged in:

- Social services
- Law enforcement
- Education
- Direct care
- Licensed health and human services professionals ([MS 214.01, subdivision 2](#))
- Employment in a licensed facility
- Medical examiner or coroner activities

## The Minnesota Adult Abuse Reporting Center

A **vulnerable adult** can be anyone over age 18 who:

- ▶ Has a physical, mental or emotional disorder that makes it difficult for the person to care for themselves without help and to protect themselves from maltreatment (functional definition)
- ▶ Is in a hospital, nursing home, transitional care unit, assisted living, housing with services, board and care, foster care or other licensed care facility (categorical definition)
- ▶ Receives services such as home care, day services, personal care assistance or other licensed services (categorical definition)

## The Minnesota Adult Abuse Reporting Center

**Maltreatment** includes:

- ▶ Abuse, including physical, emotional and sexual abuse, use of restraints, involuntary seclusion or punishment
- ▶ Neglect, including failure to provide necessary food, shelter, clothing, health care or supervision because of neglect by a caregiver or because the vulnerable adult cannot meet their own needs
- ▶ Financial exploitation, including theft or withholding of money or property and/or use of money or property not for the vulnerable adult's benefit.

## The Minnesota Adult Abuse Reporting Center

- ▶ Began receiving reports on July 1<sup>st</sup>, 2015.
- ▶ Single toll-free number: **844-880-1574**
  - ▶ Available 24 hours per day
  - ▶ Immediately notifies county agency (EPS); law enforcement (crime); Med Ex, Ombudsman for MH (suspicious death)
  - ▶ Refers directly to Lead Investigative Agency
- ▶ Online reporting for mandatory reporters

  - ▶ Merges the former Vulnerable Adult Justice Project and the Minnesota SAFE Elders Initiative
  - ▶ Incorporated February 2014, launched October 1, 2014

### The Elder Justice Roadmap

- ▶ The Roadmap, created by the National Center on Elder Abuse in collaboration with leaders in the field, identifies “the elder justice field’s most urgent needs as well as threshold barriers and challenges that must be overcome to address them.” (Roadmap, 7)

### The Elder Justice Roadmap

- ▶ The Roadmap identifies the “Top Five Priorities” pertaining to efforts to prevent elder abuse:

1. Awareness
2. Brain Health
3. Caregiving
4. Economics
5. Resources

### The Elder Justice Roadmap

- ▶ The Roadmap identifies elder abuse as “a problem with solutions.” To achieve these solutions will require conversation and multidisciplinary collaboration.
- ▶ Some responses are simple; others more complex. The Roadmap identifies that there’s a role for everyone...

### MEJC Curricula projects:

The National Center on Elder Abuse contracted with the Minnesota Elder Justice Center to produce curriculum tailored to rural, outstate and agricultural communities; and curriculum tailored members of faith communities.

- ▶ Introductory curriculum deliver-able by non-professionals, and tailored to a lay audience.

- ▶ Deliver broad, national curriculum in fall 2015.
- ▶ Tentative national roll-out in January 2016.
- ▶ Next steps: tailor for use in Minnesota.
